PROGRAM GUIDELINES

• PARTICIPANT ELIGIBILITY

- This rebate is available for residential members of electric cooperatives that are members of the Wabash Valley Power Association. A list of participating co-ops can be found at www.PowerMoves.com, or call your electric cooperative to ask if they participate in this program.
- Rebated bulbs must be installed in homes served by participating electric co-ops.
- Rebate is limited to 30 bulbs per member per calendar year.
- This rebate cannot be assigned to a third-party.

• PRODUCT ELIGIBILITY

- Program applicants and program participants may not use our logo or name without prior express written permission.
- **Only ENERGY STAR qualified bulbs are eligible for this rebate. Look for the ENERGY STAR logo on the package. Or, check the product list at www.EnergyStar.gov**
- This rebate is for bulbs only. Fixtures that contain LED bulbs are not eligible for this rebate.
- Offer good on ENERGY STAR-qualified bulbs purchased between January 1, 2017 and December 31, 2017. Application can be postmarked no later than February 28, 2018.
